On 14 October 2014, the Company entered into a Sale and Purchase Agreement with a Vendor, pursuant to which the Company has conditionally agreed to acquire and the Vendor has conditionally agreed to sell 6,000 shares representing 60% of the total issued and paid up capital of Forenzia Enterprises Limited at a total consideration of HK\$48,100,000.

The total consideration shall be payable by the Company to the Vendor by way of issuing Consideration Shares by the following schedule:

(i) 22,200,000 of the Consideration Shares had been issued and allotted to the Vendor upon the completion of the Acquisition on 11 November 2014; and

(ii) 14,800,000 of the Consideration Shares will be issued and allotted to the Vendor within 6 months after the commencement of operation of the online casino.
