(1) On 14 October 2014, the Company entered into a Sale and Purchase Agreement with a Vendor, pursuant to which the Company has conditionally agreed to acquire and the Vendor has conditionally agreed to sell 6,000 shares representing 60% of the total issued and paid up capital of Forenzia Enterprises Limited at a total consideration of HK\$48,100,000.

The total consideration shall be payable by the Company to the Vendor by way of issuing Consideration Shares by the following schedule:

(i) 22,200,000 of the Consideration Shares had been issued and allotted to the Vendor upon the completion of the Acquisition on 11 November 2014; and

(ii) 14,800,000 of the Consideration Shares will be issued and allotted to the Vendor within 6 months after the commencement of operation of the online casino.

(Please refer to the announcements dated 14 October 2014 and 11 November 2014 for details.)

(2) On 27 May 2016, the Company entered into a Supplemental Agreement with the Vendor to adjust the Issue Price of the 2nd Tranche Consideration Shares from HK\$1.30 per Share to approximately HK\$0.90 per Share. As such, an additional 6,500,000 new Consideration Shares shall be allotted and issued to the Vendor within 6 months after the commencement of the operation.

(3) The operation of the gaming business in Vanuatu commenced on 30 June 2016 and the Company has allotted and issued 14,800,000 2nd Tranche Consideration Shares and 6,500,000 Additional Consideration Shares to the Vendor on 26 July 2016.
