SUPPLEMENTAL SUBSCRIPTION AGREEMENT

SUPPLEMENTAL SUBSCRIPTION AGREEMENT is made on the 15th day of January 2021

BETWEEN:

- (1) **CENTURY ENTERTAINMENT INTERNATIONAL HOLDINGS LIMITED**, a company listed on the Stock Exchange of Hong Kong Limited having its registered office at Suite 6303-04, 63/F, Central Plaza, 18 Harbour Road, Wan Chai, Hong Kong (the "**Company**"); and
- (2) **NG MAN SUN.**, c/o Suite 6303-04, 63/F, Central Plaza, 18 Harbour Road, Wan Chai, Hong Kong of the other part. (the "**Subscriber**").

WHEREAS:-

- (A) By a Subscription Agreement dated 30 December 2020 and made between the Company and the Subscriber (the "Subscription Agreement"), the Subscriber agreed to subscribe the Convertible Bond which the Conversion Price was HK\$0.25 per each Conversion Share.
- (B) On 15 January 2021, the Company proposed to revise the structure of the Capital Reorganisation, among which, the basis of the Share Consolidation to every ten (10), instead of five (5), issued and unissued Existing Shares of par value of HK\$0.20 each will be consolidated into one (1) Consolidated Share of par value of HK\$2.00.
- (C) In this regard, the Company has requested for the adjustment of the number of the Conversion Share in connection with the Convertible Bond and the Subscriber is agreeable to adjust the number of the Conversion Share in connection with the Convertible Bond subject to the terms and conditions set out hereunder.

NOW IT IS HEREBY AGREED as follows:-

- I. Unless otherwise defined, words and expressions herein shall have the same meaning ascribed to them in the Subscription Agreement.

2. The Conversion Price shall be amended from HK\$0.25 per each Conversion Share to HK\$0.5 per each Conversion Share.
3. This Supplemental Subscription Agreement is conditional upon approval of the Stock Exchange of Hong Kong Limited on the amended number of the Conversion Share AND the Company's shareholders approval being obtained.
4. Save and except as herein modified or varied, all terms, conditions, provisions and covenants in the Subscription Agreement shall remain unaltered are in full force and effect. To the extent that any term or provision of this Supplemental Subscription Agreement is or may be deemed inconsistent with any term or provisions of the Subscription Agreement, this Supplemental Subscription Agreement shall prevail.
5. This Supplement Subscription Agreement shall be construed and governed by the laws of Hong Kong.
